I asked the coordinator questions about the new optional invoicing practice right before the meeting. For those who could not make it, I am including the Q & A below. A few invoicing questions and answers.

Q1) If we accept the new system in which the interpreter invoices the courts, what happens if the interpreter makes a mistake in the hours or amount?

A1) *All invoices submitted by you will be compared for accuracy against that week's RFP forms sent by the courts. I will continue to calculate totals, as it is part of the approval process. Should there be a discrepancy; the information in the RFP shall be the basis for the decision.*

Q2) How will the court proceed if the interpreter includes in the invoice an RFP that the AOC hasn't received yet?

A2) *I will have to ask the court to send the specific RFP ASAP. As I stated in my previous email about this, all courts are sending RFP via fax with the exception of NCC CCP and FC and they know to send them by the following Monday.*

Q3) If the interpreter practices the new invoicing method, will this now be the only request for payment, and the RFP form becomes a backup/ control device for the AOC?

A3) *The RPF is still the crucial form. This invoicing system does not change the need for the RPF*

Q4) If the interpreter starts the new invoicing system, can he/she opt out later if it doesn't work for him/her?

A4) Yes

Note: rfp/RFP stands for "request for payment form". That is the document we fill out after each assignment and have an officer sign-then make a copy for our records.
